### **3RD ANNUAL BALTIMORE/WASHINGTON SUMMER SCRATCH CLASSIC RULES**

1. Open to all male and female bowlers who are in good standing with USBC, VMSBT & non-exempt PBA members. **PBA members who are exempt for the '10 -'11 season are ineligible.**
2. Bowlers will bowl **8** games of qualifying crossing **16** lanes. After both squads have completed qualifying, the field will be cut to the match play finalist (1:7 overall, will make match-play). Those bowlers making it to the match play round will bowl **9** more games of match play with all pin fall carried forward from the qualifying. The winner from each match play game will receive **50** bonus pins. The ninth game of match play will be a position round game (i.e., #1 vs. #2, #3 vs. #4, etc.). The champion will be determined by total pin fall with bonus pins from matches won.
3. All prize money will be returned **100%** on a ratio of **1:5**. Before the conclusion of the second squad, a complete accounting of all tournament prize money will be available for participants. In the event of a protest, all monies will be withheld pending ruling of any disputes.
4. Current USBC rules governing tournament play will strictly be adhered to. The tournament director will decide any issues not covered by USBC. The tournament director's decisions shall be final unless an appeal is made in accordance with rule 329. Your payment of entry fees is your agreement to accept any decisions that may be made by the tournament director. The tournament director reserves the right to reject any entry.
5. In the event of a tie in the final game, a 9th and 10th frame roll off will be bowled to determine the tournament winner. Cash spot ties will be split evenly.
6. Check-in will start **1 hour** prior to the squad time. Lane assignments will be given at check in. There will be no more than **4** bowlers per pair of lanes.
7. Entries close after the **1<sup>st</sup>** frame of the first game of each squad. Re-entries are allowed, space permitting.
8. **ABUSING BOWLING CENTER EQUIPMENT OR INAPPROPRIATE BEHAVIOR WILL RECEIVE A WARNING. A 2<sup>ND</sup> OFFENSE WILL RESULT IN DISQUALIFICATION WITHOUT REFUND AND AN ESCORT OFF OF THE PREMISIS FROM THE ANNE ARUNDEL COUNTY POLICE DEPARTMENT.**
